## 1. Delivery

## 2. Guarantee

Should a delivery unintentionally have obvious quality deficits we kindly ask you to return the products immediately upon receipt, i.e. directly to Post Brewery Weiler, D-88171 Weiler im Allgau. You will receive a replacement delivery immediately.

The same applies to gift products like beer glasses etc..

## 3. Prices

The prices mentioned in the Post Brewery Online-Shop include statutory VAT and are indicated in Euro. The prices apply until new prices are published. Error and omission excluded.

## 4. Shipping Costs

Germany: We charge Euro 4.90 per mail order within Germany (freight and packaging) for parcels weighing up to 31.50 kgs.
